#### Item #1 – Set Public Hearing for Local Law on Best Value:

Town Attorney, Scott Volkman noted that the Town Board set the Public Hearing date at the January 14, 2015 Regular Town Board Meeting. Town Attorney, Volkman reviewed the proposed new procurement policy with the Town Board.

<u>Item # 2 – Approve Zoning Administrator to Attend Planning Conference/April 2015:</u> The Town Board had discussion regarding this matter and have agreed to move it for discussion at the March 4, 2015 Workshop Meeting.
