NOTICE OF PUBLIC HEARING

PLEASE TAKE NOTICE that on Wednesday, July 27, 2016 at the Town of Pleasant Valley Town Hall meeting room, 1554 Main Street, Pleasant Valley, NY, 12569 at 7:00 p.m. or as soon thereafter as the matter is reached on the agenda, the Town of Pleasant Valley Zoning Board of Appeals (ZBA) will hold a public hearing to consider an Application/Appeal by Central Hudson Gas and Electric Corporation (Central Hudson) from an Administrative Decision of the Town Zoning Administrator, dated May 24, 2016 (Decision), with respect to the proposed rebuild of the 69kV G-Line North Electric Transmission Line which runs within an existing utility right-of-way for an approximately 3.6 mile distance, commencing at the shared boundary of Pleasant Valley and LaGrange, running in a northerly direction to Central Hudson Tower T-1494, approximately 1.4 miles north of the Tinkertown substation, which Application/Appeal seeks the following relief:

1. A height (area) variance from Pleasant Valley Zoning Law Sections 98-12 (Schedule of Area and Bulk Requirements, 98 Attachment 2) and 98-13A to allow a maximum height for the transmission line of 75 feet, where the zoning limits the heights as follows:

RR District: 35 feet RA District: 35 feet SFH District: 35 feet LDR District: 35 feet Q District: 40 feet O/I District: 30 feet

The variance request is a unified application for the entire line, given the necessary interrelationship between the heights of the new poles, the pole spacing, topography and several required clearances. Within this unified application, the Board will consider all elements of the proposed rebuild project as they relate to the Application/Appeal. A table identifying the parcels crossed by the proposed line and the parcels upon which a pole is proposed, showing the height of each proposed pole, is incorporated in this Notice (see below). A map showing the location of the G-Line North in Pleasant Valley is enclosed in all mailings of this Notice of Hearing, and available on the Town web-site and at Town Hall. Existing G-Line poles range in height from 40 to 77 feet. New poles will be self-weathering steel, approximately 52 to 75 feet tall, which is approximately 10 to 15 feet taller on average than existing poles. The rebuild will reconfigure pole location and conductor spans and will reduce the number of poles from approximately 58 to 50.

2. In the alternative, an interpretation reversing the determination of the Zoning Administrator and determining that Central Hudson's proposed rebuild project does not require a height variance from the height limits set forth in the Pleasant Valley Zoning Law sections cited in the above section.

3. An interpretation or acknowledgement that the ZBA has inherent authority to grant extensions of the one year period within which area variances must be exercised under Zoning Law Section 98-95B(3)(b) to avoid expiration, and in the alternative, if such interpretation or acknowledgement is not granted, a variance of the provisions of Section 98-95B(3)(b), to declare that the 1 year period for exercise of any variance granted in this case shall commence upon the authorization to commence construction, by building permit or otherwise, rather than upon issuance of said variance.

PLEASE TAKE FURTHER NOTICE that a coordinated SEQR review has been undertaken for the G-Line North project in both the Town of Pleasant Valley and the Town of LaGrange, as a Type I Action, and that the LaGrange Planning Board, as the SEQR Lead Agency, determined on May 19, 2016 that the proposed project will not have a significant adverse effect on any aspect of the environment, and adopted a Negative Declaration and Notice of Determination of Nonsignificance. A copy of the Negative Declaration is on file in the Zoning Department at the Town of Pleasant Valley at the above Town Hall address. The G-Line North project occurs partially upon land within agricultural districts containing a farm operation, or within 500 feet thereof, and an Agricultural Data Statement has been filed with the Planning Board.

AT THE PUBLIC HEARING, all interested persons shall have an opportunity to be heard. Written comments will also be accepted if received prior to the later of July 27, 2016, or the last day of the public hearing, if adjourned beyond July 27, 2016. Written comments will also be accepted at the Public Hearing on July 27, 2016 or at any adjournment thereof. E-mail comments will also be accepted if received during regular business hours (Mon-Thu: 9am to 4pm, and Fri: 9am-1pm) prior to the later of July 27, 2016, or the last day of the public hearing, if adjourned beyond July 27, 2016. A copy of the Application/Appeal and a copy of the Plan and Profile drawings showing the location of the proposed rebuilt line and the pole heights are available during business hours in the Zoning Department at the Town of Pleasant Valley Town Hall.
